- Winter Court 5 uses the canon story and lore as a base to tell its story, albeit some facts may have been changed see our history documents for more information.
- While the option to play as a character loyal to Daigotsu Kanpeki is an available option in the list of Clans and Factions available for Winter Court 5, any players who are chosen to play as members of that Faction should be aware that Winter Court 5 is an advanced play-style and that all actions of their characters will have the proper consequences, and that all other characters of all other Clans and Factions will be allowed to respond in-character as appropriate to their Clan's or Faction's viewpoints.
- The Colonial Mantis are the faction of Mantis residing in the Colonies, swearing allegiance to the Warlord Arashi.
- Nativist Mantis are the Mantis who follow Yoritomo Ichido and the Iweko Dynasty.
- Scorpion Loyalists swear fealty to the Onyx Empire, whereas the Scorpion Traitors are the faction that were exiled to the Burning Sands (but are still Scorpion!).
- The Emerald Spider are the Spider Clan who follow Susumu Shibatsu, while the Onyx Spider are those who swear their oaths to Daigotsu Kanpeki.
- Those wishing to play a member of a Minor Clan may be surprised to see only a generic listing in the list of choices; the specific Clan will be determined later. The Clans available are all of the Minor Clans presented in the core *Legend of the Five Rings Roleplaying Game* rulebook, except for the Snake and the Falcon.

For the next set of questions, please read the following scenario and then answer the questions based on the information presented in the scenario.

Scenario: You are in the role of Kakita Hanzo (Honor 7, Status 3). You are a very skilled duelist and possess one of the famed Kakita blades. You are in the village outside of your host's castle enjoying a bowl of noodles when a child approaches you and rather boldly at that. The boy calls out to you:

[&]quot;My father says you make inferior weapons."

The child is Gyushi Tetsuya (Age 7, NPC). His father is further down the street, a Shugenja named Gyushi Hattori of the Spider Clan loyal to the Emperor's brother. Hattori (Status 3) has personally had friendly relations with a few of your fellow clansmen this season (as far as you know) and is in negotiations to trade rice for Crane iron. Hattori browses and admires one merchant's collection of ceramics and does not seem to notice his son is speaking with you. 14. How do you respond to the kid's statement?

For the next set of questions, please read the following scenario and then answer the questions based on the information presented in the scenario.

Scenario: You are playing the role of Kitsuki Segata (Honor 4, Status 4), a Kitsuki Investigator. You are hot on the trail of an assassin that has poisoned and killed a prominent Otomo bureaucrat. Through your brilliance and sleuthing, you suspect that the killer may be the castle stable boy whom you typically see grooming the horses at this hour each night. The young man is bigger and stronger than you, and you cannot gauge his willingness to resist arrest. You want muscle to back you up and quickly before he catches on to you and escapes justice. You are in the castle gardens seeking what aid you can and find Yoritomo Sanshiro, another PC who has shown great skill in kata demonstrations this season. You initiate conversation in hopes of persuading him to join you. However, another player suddenly posts the following message:

Pastels exploded into a storm of colorful petals. The sound of ceramic shattering against stone was like thunder. The sweet fragrance of a perfectly fine sake steamed upward. whatever abstract ikebana display that had been, part of the aftermath dampened the clothes of the great detective Kitsuki Segata, granting him an equally fragrant scent of rice wine. Sitting flat on the same ground of the broken vessel, torn flowers and wasted sake, a young woman in Phoenix colors stared dumbstruck at her faux pa. She grimaced, holding back her panic, but had no words to release.

The Phoenix woman is Shiba Haruhi (Status 1), an artisan and player character whom you have seen but never met.

There is a Crane who prays there each night and we will need to procure the red fan printed with a camellia she carries one way or another. See that this is done.

Metagami's player has been making bold statements in the private embassy threads about having a capable network of spies. This is in spite of that player having little to no correspondence with the GMs or any of their NPCs. You do note that there are several threads started by an Asahina Ryuko at the shrine, but all such threads are marked "Private" with no other Scorpion players posting there. Also, at no point have you even heard rumors of a red fan marked with a camellia... except on those very threads where Ryuko has been using it as a focus in some sort of commune ritual with the Fortunes.

For the next set of questions, please read the following scenario and then answer the questions based on the information presented in the scenario.

Scenario: You are in the role of Akodo Katsuhiro. A player, Ide Ayeka, approaches you with a private message stating that the player of Ikoma Miyabi has been approaching them with some rather lurid questions about their personal life. Katsuhiro has a much higher status than Miyabi in-character and Ayeka's player appears to be looking to you for guidance but also wants to resolve this without including the involvement of a GM. As far as you can tell, nothing appears to be happening between the two that does not seem questionable on the forums.
